

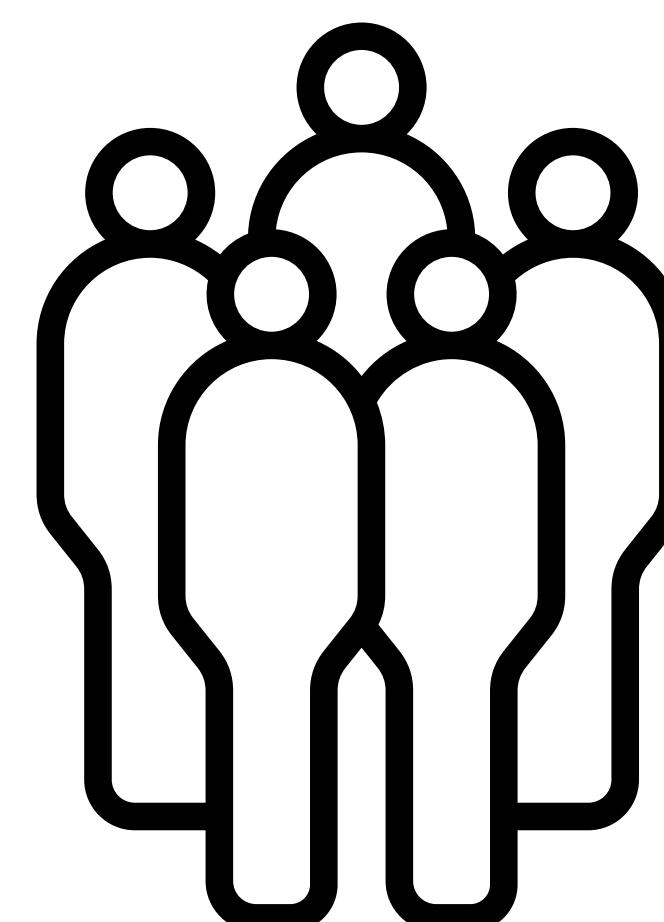

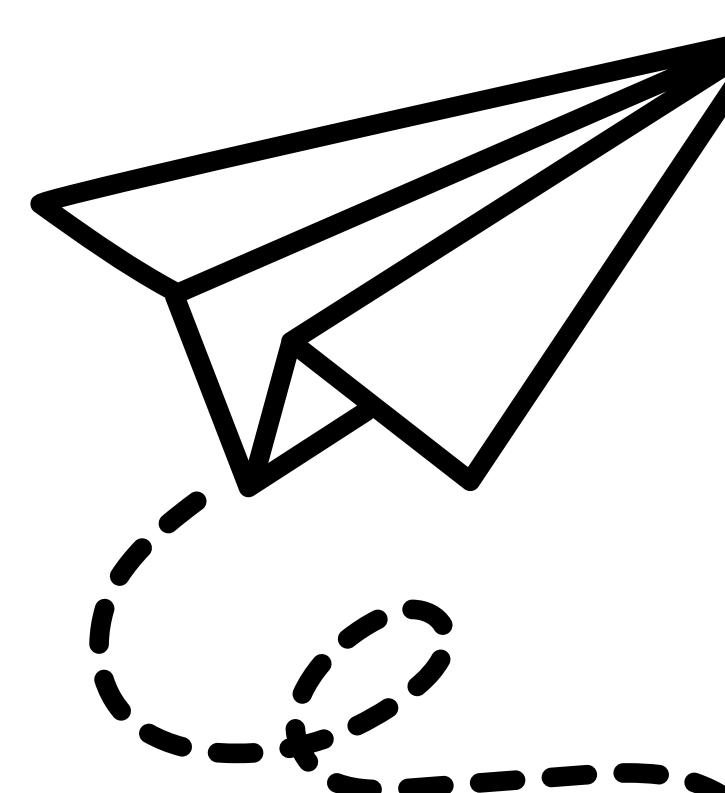

FILE SUBMISSION GUIDELINES

Images: High-resolution RGB .jpg or .png (300 ppi or higher), and .eps or .ai files for logos.

Ads: PDF or High-resolution JPG, with all fonts embedded or converted to outlines.

Copy/Text: Small stories (300-600 words) or longer stories (up to 1200 words) should be submitted as a .doc files with no restrictions set.

Links: All hyperlinks should be active, and include the full link and its intended location.

Note: Ads that do not meet these specifications will be rejected and will need to be resubmitted before publishing. Changes made may incur additional production fees.

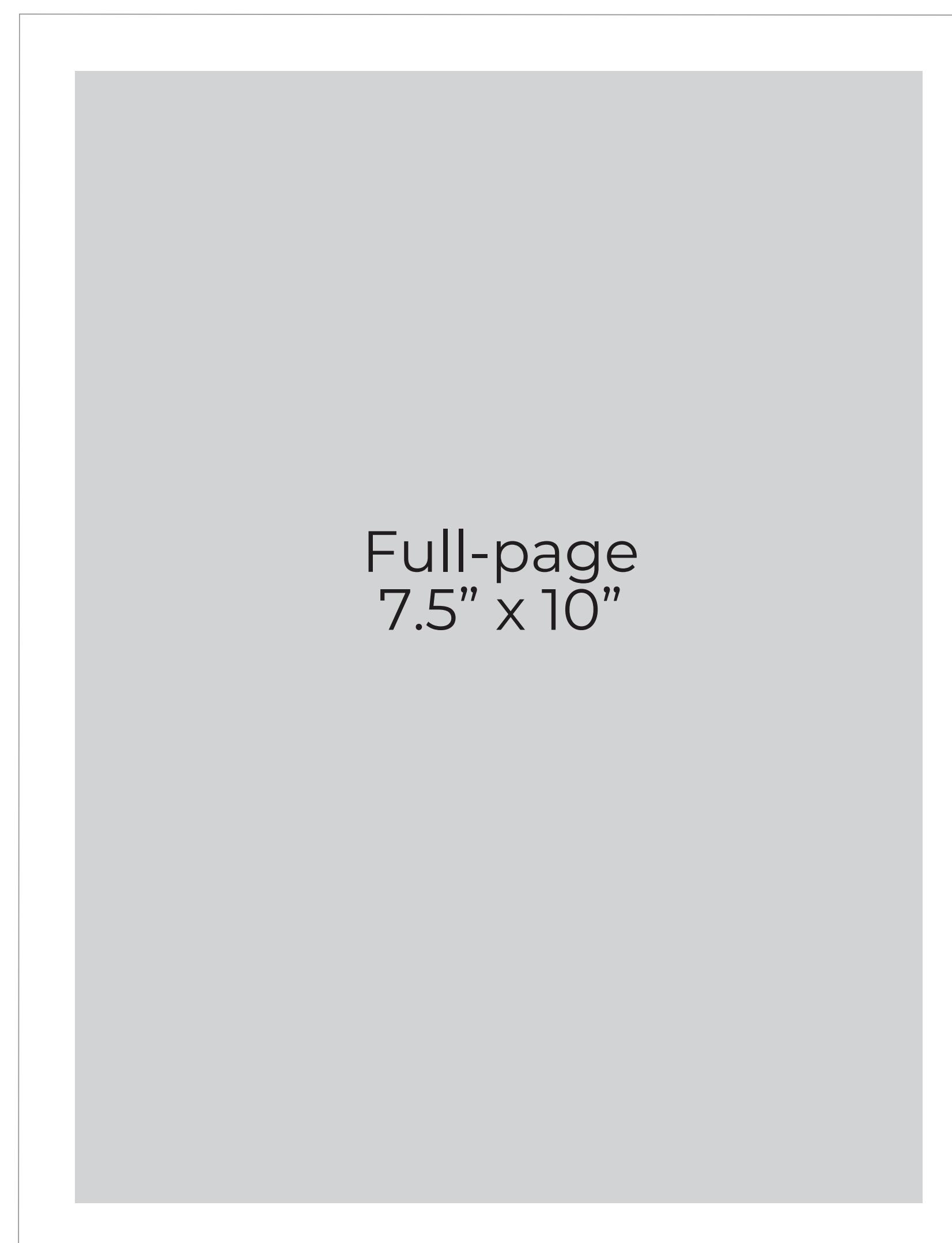

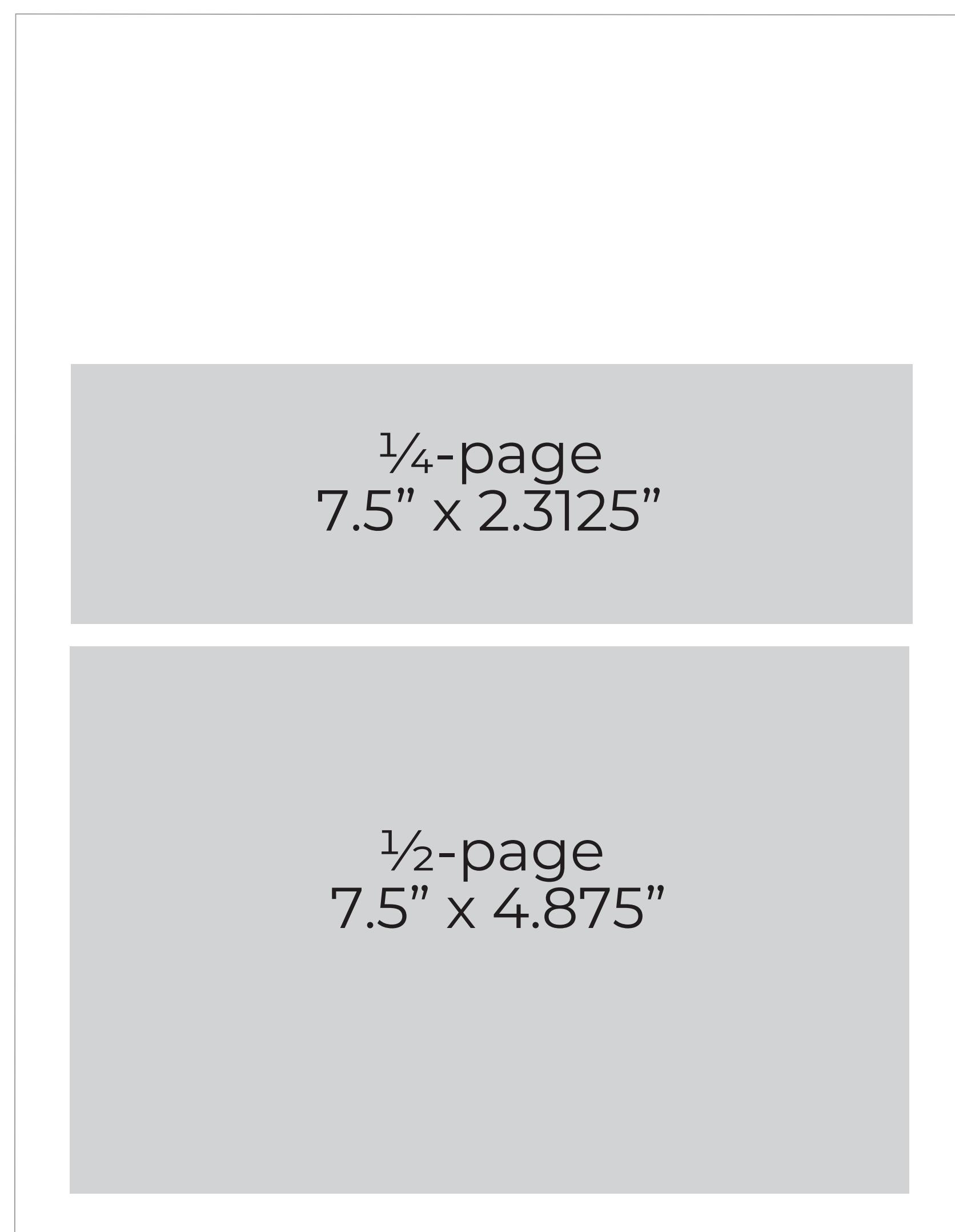
